# Have Your Say!!!!

A major review of our Constitution (Rules of Association) is upon us.

## **This is the opportunity to get it right.**

From time to time ambiguities in the current constitution have caused issues in the efficient running of the Society. In this issue of Roundup suggested changes are detailed based on interpretation of the existing constitution after research by the subcommittee, hopefully eliminating those ambiguities.

## **We want your input on your Rules for your Society.**

In recent times concerns have been raised as to the fairness and appropriateness of provisions in the Rules, some examples are listed below.

**Voting:** By presence or proxy at the general meeting.

**Proxies:** Limited to one per member present at meeting and available to members 75 Km by road distance from Adelaide GPO OR members who are sick or committed to work.

**Executive:** Has same powers as Committee but must have 75% present and have decisions ratified by next Committee meeting.

**President:** Has deliberative as well as casting vote at both General and Committee meetings.

**The Committee:** (currently 17 potential for 24 plus) comprises the Executive (up to 7 elected at the AGM), the State Convention Convenor- SCC. (appointed by the Committee), SACA Rep (appointed by SACA), SARDA Rep (appointed by SARDA) and up to 14 Club Reps (currently 7 appointed by their clubs.)

Originally the Society was managed by the Executive and the Club Representatives were liaison persons without voting rights. This was changed to expand management to a larger group by including the SCC and all club representatives as voting members, this step expanded the committee to fourteen members. We believe a workable Committee should be limited to around twelve voting members all appointed by Society Members.

**Your suggestions as to how this could occur are welcome.**

Please submit any comments to Scotty Scott, Secretary or Graham Burgan, Chairperson as soon as possible, contact details on the back page. We are using this period of no dancing to progress on these administrative changes. As submissions come in and the sub-committee deliberate, we will publish options for each rule for your response in Round Up. These rules instruct the Committee on the will of the members in management of the Society and need to be carefully drafted.

# A family history of Square Dance

Who else can say that almost the whole of their family met their original partners through square dancing? My parents met through square dancing in 1951 in Norwood, South Australia. Over the years they had four children, 3 girls (of which I was the third) and 1 boy. In the 1970s Barry and Danni Jordan, the parents of good friends of my sister, and my brother decided to start a square dance club in Elizabeth, South Australia called "Bunch of Squares". It was predominantly a club made up of teens, who were looking for something to do, and this was seen as a great and safe way for these teens to socialise. I can remember the founding members (of whom I was one) thinking it would be hilarious to call the club this, as square dancing, even then, had the image of only something "squares" would do, in the younger set. Barry decided to run with the joke, and thus the club was born and registered. Over the years the club flourished and moved to a hall in nearby Salisbury, South Australia. My older sister, myself, and my brother, all met our future original partner through this club.

The pictures below show the dress set for this club in 1979, attending the South Australian Square Dance Convention and includes myself, my brother, my best

friend's brother and the father of my children, my original partner, as well as two of my good friends. We decided on a rainbow set, each couple having a colour, with the background black, and same basic pattern, so that if a couple couldn't make a convention, or a show where we held a display, a substitute couple could easily fill in. Can you pick me? I was skinny then!

Photos also include a very young Jeff Seidel, and Kevin Kelly. All hairdos are for your current amusement!

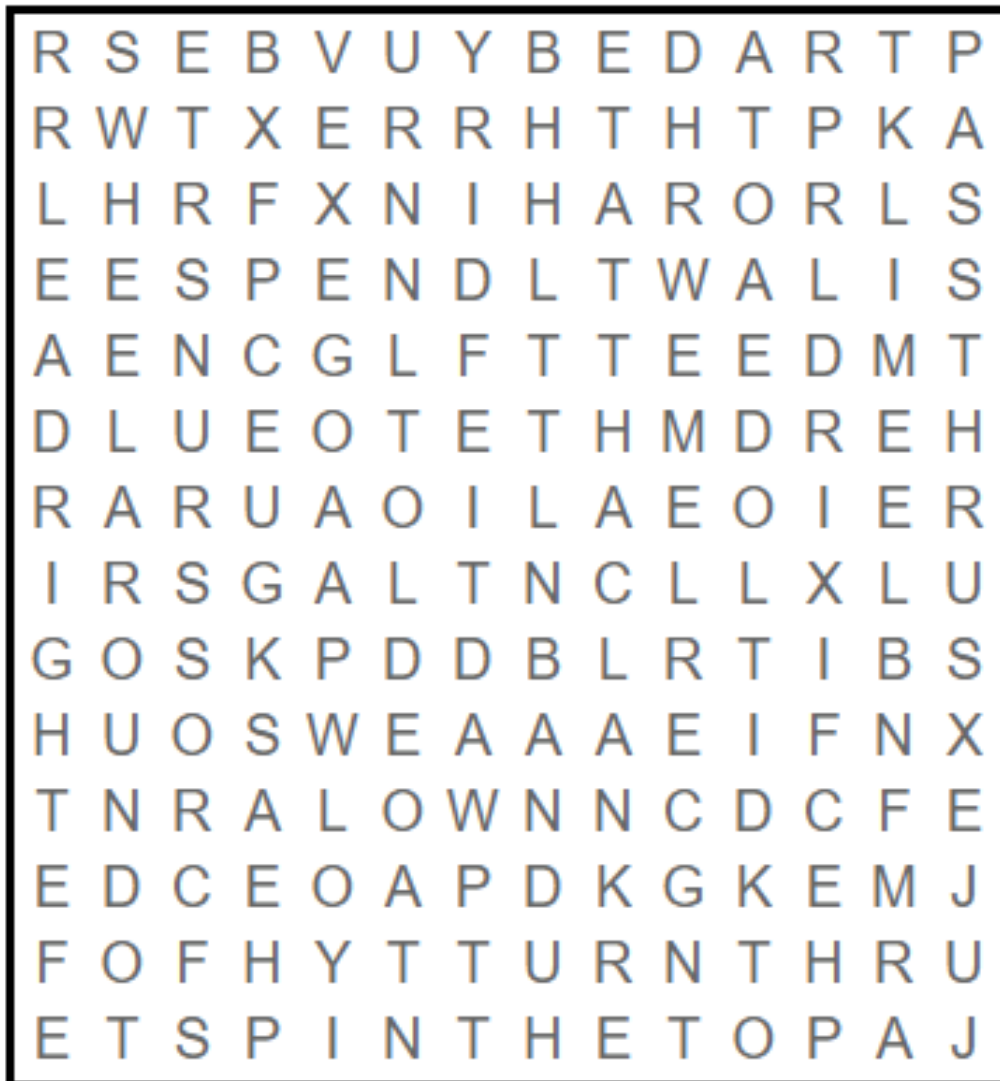
