360 gms soft butter 2/3 cup sugar

1 tin condensed milk 1 pkt chopped dried apricots

1 pkt white choc chips 2 heaped cups SR flour

Method:

Cream butter, sugar and condensed milk with electric beater.

Add flour, choc and apricots and mix together.

Place teaspoonful on tray with baking paper

Cook at 180 deg for 13-15 minutes or until golden. Cool on tray

Procedural Motion: Moved Chris Wood, Seconded Steve Petrone 'That the motion is not put' **Carried.**

Therefore, the motion was not put.

Les Tulloch proposed that it be noted in the minutes, that Anne Tulloch be thanked for her work in sorting out the Bank Accounts and accounts for payment following the resignation of the Treasurer **Carried by acclamation**

Graham Burgan proposed that it be noted in the minutes that, Diana Waters, Pauline Ottaway and Don Stephens be thanked for their service to the Society as executive members **Carried by acclamation**.

MOTIONS OF AMENDMENT (Nos. 1-7) 2021 TO MOTION No. 1, 2020 AGM (Adoption of New Rules of Association) (Tabled by procedural motion at 2020 AGM "not to vote on adoption of Rules".)

PREAMBLE

Due to the rejection of the "General Representative" concept in the proposed Rules, favouring a continued Club Representation, the Committee, after considerable deliberation by its Rules Sub-Committee, recommend the following and give due notice to members of the intent to resubmit the motion to "adopt the Rules" at the 2021 AGM with all approved amendments below.

Motion 3 is the main amendment concerning representatives.

During the process, the Sub-Committee found other sections of the Rules to amend, giving seven (7) amendment motions. Please read these, along with the Rules published in the November 2020 "Round Up".

(Motion 1) A few changes to Descriptions.

(Motion 2) The adding of two (2) additional Objectives.

(Motion 3) To maintain consistency with other changes by making the Rules less specific, the appointment of representatives has been moved from the Rules to guidelines (Bylaws). This should be read in conjunction with new document **M-00 SASDS Members Bylaws** (Motion No. 10), referring to Club Representatives and all references to guidelines (Bylaws) in the Rules.

(Motion 4) Amendments to clarify the wording in 9.1. Annual General Meetings (AGMs) including the change from "Confirmation of minutes" to "Ratification of the Committee confirmation of the minutes".

(Motion 5) Clarification to reflect the intent that the Society accounts be operated by the four (4) listed Executive Officers with two (2) to sign, rather than, as exists, being operated by {only} two (2) of the four (4).

(Motion 6) The concept of "guidelines" approved by either Society members or the Committee is complicated and confusing, so these are replaced with "Bylaws" and "Regulations" respectively.

(Motion 7) Allows for the later correction of minor errors that do not affect the meaning of the wording.

The intended procedure at the AGM will be to ask members if they have any objections to any motions.

Those motions without objection shall be grouped and voted on together in one vote.

Any objected motion shall then be put independently.

Amendments cannot be taken from the floor as twenty-one (21) days' notification is required for Special Resolutions.

Those amendments that are passed shall alter the original motion to "adopt the Rules" which will then be put.

Motion No. 1 - Changes to Descriptions

- A) In Clause 2.3. add the words "noted in Clause 7.3.c." after the word "Society".
- B) In Clause 2.6. replace "a). which dances a programme recognised in the guidelines agreed by the Society members and normally dances at least once a fortnight;" with "a) which is a Square Dance Club, dances a programme recognised in the guidelines agreed by the Society members and normally dances at least once a fortnight;".
- C) Add new section to Clause 2.6. "and c) which may be in recess for a period laid out by the Committee and to be documented in the Committee's guidelines."
- D) Add new Clause 2.11. "a) "Guidelines approved by Society members" shall mean additional requirements set down by members by Ordinary Resolution at a General Meeting. b) "Guidelines approved by the Committee" shall mean additional requirements set down by the Committee."

Motion No. 2 - Added Objectives 3.9. & 3.10.

- To respect the autonomy and differences of the individual Clubs and promote their freedom in running Clubs in respect to matters such as pricing, callers, dates of dances, levels of dancing etc.
- 3.10. To plan and conduct the Society's financial affairs in such a manner as to generate surplus funds adequate to regularly fund its operating expenses, special events, research projects, promotional campaigns, capital purchases, equipment replacement and the like.

Motion No. 3 - Moving Committee Composition to Guidelines

- A) Replace the existing Clause 7.3.a. with the following: "The Committee shall comprise of the Executive and no fewer than six (6) representatives appointed to the Committee according to guidelines to be approved by the Society members (subject to Clause 7.3.e.). The representatives shall be registered with the Secretary and shall be excluded from the quorum if absent from three (3) consecutive meetings."
- B) In Clause 7.3.b. remove the words "Recognised Club,".
- C) In Clauses 7.3.e. and 7.3.j. replace all references to "General Representatives" with "representatives".
- In Clauses 7.3.g. and 7.3.h. remove all references to "General Representatives" and their election.

- In Clause 7.6. remove from the heading "(This clause will operate only for the transition years 2020-22)".
- F) In Clause 7.6.a. replace "Any person elected at the 2020 AGM, regardless of these Rules, shall complete their current term." with "Any person in one of these positions at the time of the adoption of these Rules shall remain until the next scheduled election for that position.".
- G) Delete Clauses 7.6.a.i., ii., iii., iv., v. and vi. in their entirety.
- H) Delete Clause 7.6.c. and replace with "Any guidelines mentioned in these Rules requiring Society member approval that have not been approved at the AGM shall apply as interim guidelines determined by the Committee, provided that such are approved and/or amended by the Society members at the next AGM after the Rules are adopted,"
- Replace any other references to "General Representatives" with "representatives".

Motion No. 4 - Alter or Insert the Wording Highlighted in "Yellow"

9.1. ANNUAL GENERAL MEETINGS (AGMs)

- 9.1.a. The Committee shall call an Annual General Meeting each year in accordance with the Act and within six (6) months of the end of the financial year of the Society unless exempted under the Act. The items of business at the meeting, as ordered by the Committee in a published agenda, shall be:-
 - Ratification of the Committee confirmation of the minutes of the previous AGM and of any Special General Meeting held since that meeting.
 - Consideration of the accounts and reports of the Committee and the Financial Reviewer's report.
 - Declaration of Scrutineers, Reference Group and Returning Officers as applicable.
 - 9.1.a.iv. The election of Committee members.
 - 9.1.a.v. The appointment of a Dispute Committee.
 - 1.a.vi. The appointment of a Financial Reviewer.
 - 9.1.a.vii. Any other b Business requiring consideration by the Society in an AGM for which due notification has been given.
 - Any other business the meeting wishes to refer to the Committee.
- An AGM may be postponed at the discretion of the Committee by an Ordinary Resolution.

9.5. PROCEEDINGS AT REQUIREMENTS FOR GENERAL MEETINGS

Insert below the heading: "Additional General Meeting procedures shall be determined in the guidelines to be approved by Society members."

 Minutes of an AGM or SGM will be released to the members as per the guidelines.

9.6. VOTING AT GENERAL MEETINGS

9.6.b. Any member eligible to vote at the meeting may apply for a proxy. The proxy holder may have multiple proxies as determined in the guidelines established by the Society members. The official proxy form should be used giving the maximum possible notice, to be presented to the Returning Officer within the time specified in the notices for a proxy.

Motion No. 5 - Alterations to Financial Clauses

- A) Delete Clause 11.2.a. and replace with the following: "The Committee shall operate an account or accounts with a recognised financial institution of all monies belonging to the Society. Such account/s, electronic or otherwise, shall be authorised by any two (2) of the following signatories to the accounts: – President, Vice President, Secretary, Treasurer."
- B) Insert new Clause 11.2.d.: "At the discretion of the Committee, a sub-committee may open an account for the duration of the sub-committee. Accounts created for sub-committees shall have the Society Treasurer and at least one (1) other Society signatory (refer Clause 11.2.a.) along with the Convenor/Chair and Treasurer of that sub-committee as signatories."

Motion No. 6 - Replacement of the Term "Guidelines"

Replace the references to "guidelines" with either "Bylaws" or "Regulations".

"Bylaws" shall be those guidelines that need to be approved by Society members.

All other guidelines shall be Society "Regulations".

Motion No. 7 - Correction of Minor Errors Within the Document

Grammatical, punctual, and other minor corrections can be made provided that they do not change the meaning of the Rules.

Delete Clause 5 and replace with the following:

- Ballot papers shall be pre-prepared for all positions with known candidate names.
- If equal to or more than the available positions are then achieved, no further nominations shall be taken from the floor.
- The current holder of a position is not to be highlighted on the ballot paper.

Motion No. 9 – Alter Document MG-001 to be Renamed "M-04 Conducting Committee Meetings"

Clause 1.

Insert the words "public liability" before "insured".

Clause 6.

Replace references to "guidelines" with "Bylaws or Regulations".

Clause 9.

Add the wording highlighted in yellow:

Quorums shall be as specified in the Rules.

Committee meetings: fifty percent (50%) plus one (1), including at least two (2) Executive members, and all invited to attend.

The quorum for such shall be determined as relating to the Executive positions filled (up to five (5)) plus any representatives registered with the Secretary who have attended within the last three (3) meetings.

Executive meetings: seventy-five percent (75%) and all invited to attend.

Clause 11.

Replace the entire wording with "Audio recordings of meetings shall be held for at least two (2) years."

Clause 12.

Replace the words:

"Where possible, Sub-committees to include General Representatives and non-Committee Society members, should be used in lieu of Executive meetings."

with:

"Where possible, sub-committees, to include non-Executive Committee members and other Society members, should be used in lieu of Executive meetings."

All representatives of Clubs within the seventy-five (75) kilometre range will be required to attend Committee meetings in person to vote unless exempted by the Committee (no proxies will be allowed).

A tied motion shall be considered defeated where the status quo can be determined. When two (2) equal alternatives remain in a ballot or motion then the resolution shall be determined by a draw from ten (10) numbered balls where the alternatives are allocated as odd or even.

10.1. MEETING MINUTES

All meetings, whether General, Committee or Executive, shall have minutes kept, confirmed and filed. Such minutes may be written, typed or electronic. If an audio recording is made it shall be retained for at least two (2) years.

11.2.d. SUB-COMMITTEE ACCOUNTS

Sub-committees that receive major moneys or make major expenditures on behalf of the Society shall operate their own account for such purpose, opened by the Treasurer of the Society, with a minimum of four (4) signatories with two (2) to sign (refer to Clause 11.2.d.).
